If you are traveling from the North, take I-5 Exit 234A. Go west about 100 yards (signal) and turn right onto Pacific Blvd SE. Go under the Interstate bearing right onto Knox Butte Rd E. Just past the Comfort Suites Motel, turn right into the Linn County Expo Center.

If you are traveling from the South, take Exit 234. At the stop sign, turn right onto Knox Butte Rd E. Just past the Comfort Suites Motel, turn right into the Linn County Expo Center.

If you haven't been to the fairgrounds before, please note....the RV sites are behind the main buildings along the fence line that backs up against the airport.
